Texas Education Freedom Accounts are a new education funding option that allows eligible families to use state-supported funds toward approved educational expenses.

CHAPTER 1

WHAT ARE TEXAS EDUCATION FREEDOM ACCOUNTS?

Texas Education Freedom Accounts (EFAs) are a new way for families to access and use education funding. Instead of education dollars being tied exclusively to a traditional public school, EFAs allow eligible families to direct those funds toward approved educational options that better fit their child's needs.

In simple terms, Education Freedom Accounts allow funding to follow the student, not the system.

Under an EFA program, the state sets aside a portion of education funding into an account for an eligible student. Parents then use those funds for approved educational expenses through a secure platform.



This approach recognizes an important reality:

LEARNING DOES NOT HAPPEN IN ONLY ONE PLACE OR ONE WAY.

What Makes EFAs Different from Traditional School Funding

Traditional education funding is typically assigned to a specific school or district. Families who need flexibility often must choose between limited options or absorb the full cost of alternatives themselves.

Education Freedom Accounts change that dynamic by:

- Giving parents direct purchasing power
- Allowing choice among approved education providers
- Supporting learning that happens beyond a physical campus
- Encouraging educational models that adapt to student needs

Rather than asking families to fit into a system, EFAs allow families to **build an education around their child**.

CHAPTER 2


